Proceedings of the Meeting

The parents of Ms. Ayushi Rohilla (father and mother) visited the campus along with the student for a disciplinary meeting scheduled on 22nd February 2024 at 04:30 PM. The committee examined the written complaint and reviewed the evidence presented.

The CCTV Camera Footage was checked on 3rd floor for authorizing the evidences for the case.

Findings of the Committee

- The evidence reviewed clearly supported the complaint.
- The committee unanimously confirmed the allegation against the accused student.

Action Taken

- A formal warning was issued to Ms. Ayushi Rohilla.
- Parents were advised to seek counseling support for the student to help her gain clarity and understanding regarding the misconduct.
- The stolen amount was returned by the parents to the Class Coordinator, who subsequently handed it over to the complainants.
- An apology letter was submitted by Ms. Ayushi Rohilla to the Discipline Committee, acknowledging the misconduct.

Conclusion

The Internal Complaints Committee addressed the complaint in a fair, transparent, and timely manner. The issue was resolved amicably with corrective measures, ensuring discipline, accountability, and student welfare. No further complaints of a similar nature were reported during the period under review.
